- NO PASSING - SPEED LIMIT FOR ALL CONTRACTOR VEHICLES IS 25 MPH  
**15 MPH ON ALL TAXIWAYS. WHEN WORKING ON OR NEAR TAXIWAYS, CONES, FLASHERS AND REFLECTIVE VESTS MUST BE USED.**
- NO PARKING ON ANY STREET WITHOUT CONES AND/OR HAZARD LIGHTS
- NO DISRESPECT TO, OR CONFRONTATION WITH, ANYONE. OBEY INSTRUCTIONS FROM SECURITY
- VEHICLES OVER WEIGHT, OVERSIZE OR PULLING TRAILERS – SOUTH GATE USE ONLY
- NO LITTERING ANYWHERE IN SPRUCE CREEK. BATHROOM ACTIVITIES ONLY IN A PROPER FACILITY
- NO RUNOFF IS PERMITTED ONTO ADJACENT PROPERTIES, STREETS OR TAXIWAYS
- NO PARKING IN AIRCRAFT RIGHT OF WAY - ALL VEHICLES MUST BE KEPT 30 FEET FROM THE CENTER YELLOW LINE. AIRCRAFT ALWAYS HAVE THE RIGHT OF WAY
- THE PARKS AND COMMON AREAS ARE FOR RESIDENT'S EXCLUSIVE USE ONLY
- NO FISHING ALLOWED ANYWHERE IN SPRUCE CREEK. NO PETS ALLOWED AT ANY TIME
- NO UNAUTHORIZED WORK ON SUNDAYS OR HOLIDAYS. ALLOWED WORK HOURS ARE 7AM TO 6PM MONDAY-FRIDAY AND 7AM TO 3PM ON SATURDAYS
- NO PARKING OR DRIVING ON PRIVATE OR RESIDENT PROPERTY WITHOUT EXPRESS PERMISSION
- NO LOUD VEHICLES, MUSIC OR OFFENSIVE LANGUAGE IS ALLOWED
- NO UNAUTHORIZED OPEN BURNING ANYWHERE IN SPRUCE CREEK
- NO SOLICITATION OF ANY KIND IS PERMITTED WITHIN SPRUCE CREEK
- DO NOT PLACE TRASH OR YARD DEBRIS AT THE CURBSIDE DEBRIS MUST BE REMOVED FROM SPRUCE CREEK BY THE CONTRACTOR NO DUMPING ANYWHERE WITHIN SPRUCE CREEK
