No RFID will be issued without proper verification. **A copy of the lease, driver's license, insurance card and vehicle registration must accompany this application.** RFID's will expire with the lease expiration date and can only be renewed with a new lease. **POA/Security needs a copy of the lease renewal.** In cases of long-term open ended leases, a **written statement from the Landlord or Landlord's agent** will qualify as a lease extension. It is the responsibility of the parties concerned to notify the POA/Security when the lease is terminated. All RFID's are to be removed from vehicles and destroyed at the time the vehicle is disposed of or when the party to whom the tag is assigned is no longer a renter/resident in the Spruce Creek Fly-In. **At that time, notification must be made to the POA or Security office.** Proper use of all RFID's is the direct responsibility of the resident/owner. RFID privileges may be suspended for all vehicles at the discretion of the Board of Directors for non-compliance with Spruce Creek documents including the C&R's and Rules & Regulations, for non-payment of assessments on the rental property and/or traffic or parking violations.
